Dear El Camino Hospital and Board et. al.,

Would you kindly tell me the name of the person who ordered my removal from your hospital last September 21 at sometime after 4pm that day. I would like to formally request an explanation of this incident. And the names of everyone involved in it. As well as their lines of supervision and how they came to be acting outside of them.

And how Ryan Ravenera (name on tag) came to be there at the time. His title, line of supervision and what authority he was acting under, his supervisors? As well as (according to the name tag) Sele Setefano who told me I was only allowed to be in the hospital if I needed medical attention.

I tried to explain why I was there fruitlessly only to hear the police had been called. Could you tell me the name of the person who called the police. And why I was never allowed to explain my situation to a law officer? And why Sele took my left arm by force intending to take me into an elevator with Ryan on the right without asking my permission first. And why I had to *ask* his intentions of him. And why I had to raise my voice to make sure I had witnesses hearing my request to be able to take the *public* exit out. Fortunately Wes Alles appeared at the top just in time. I would have missed him completely that day and immensely grateful I didn't.

I have some business I need to conduct with various departments in the hospital and would like to be assured that in the future I'll be able to do so in a respectful, dignified and responsive fashion without any more of this nonsense -- it's not what I'd call "Mental Health".

I would like some return calls from Drs. ~~Havel~~ and Zumarraga. As well as Dr. Adrian Grant whose name I have been unable to find in the medical records. And I need to set up interviews with a few others.

I gather many of your medical records are transcribed. Missing from the records is the name of the transcriber. Other names are missing I've already told you of in the first speech I gave to the hospital.

And finally I would like to express my gratitude to Pat Ryan for showing me something I had been glaringly been missing. I *do* have an appointment with Dr. Havel.

And I wish to thank Ken Graham and Cal James (and a few others) for encouraging me to communicate with the hospital. "And it says President!" I told Cal James when I first saw it on his name tag. Of course it would.
